PART II

DOCUMENTS AND INFORMATION ACCOMPANYING THE LICENCE APPLICATION

1. Recent lists of the accounts the applicant holds regarding any financial or commercial activity carried out, demonstrating the financial situation of the company's operations. The lists must include the profit or loss accounts and balance sheets pertaining to the last three fiscal years, along with copies of the last audited annual accounts, if prepared.
2. A general statement on the business proposals for the applicant's undertaking related to the application for the next 5 years.
3. In general, in the case of applications for generation licence or generation licence amendment, the following information shall be required. In case the application refers to only one station already in operation at the time the application is submitted (including the case the Authority applies for a licence for its already operational station) the following information shall not be required:
 - (α) (a) the construction and commissioning schedule.
 - (β) The information of the applicant or any other partner or subcontractor whose experience the applicant will rely on, indicating that they are adequately skilled for the activities covered by the application and
 - (γ) details on the energy efficiency level expected to be achieved by the proposed station, along with substantiated calculations provided by the station's manufacturer and/or contractor.

4. Please provide a summary of the preliminary financial planning regarding the activities covered by the application, including the annual cash inflow projections, divided into main cash inflow and outflow categories over the duration of either:
 - (α) the upcoming 5 years or
 - (β) the plan's technical life, if longer.

5. Please, state the possible funding sources of both applicant and plan, in a format clearly demonstrating the financial feasibility of the undertaking covered by the application.
