The technical and professional ability of economic operators is found in "PART A: INSTRUCTIONS TO ECONOMIC OPERATORS", paragraph 6.2.3. The profile of the candidates such as the working experience and qualifications they must possess are described in paragraph 5.1 of Annex II. TERMS OF REFERENCE - TECHNICAL SPECIFICATIONS of the Tender Documents.

More information on the tender itself can be found in section 2 of Annex II. TERMS OF REFERENCE - TECHNICAL SPECIFICATIONS where the overall objectives, purpose and expected results are described. Also in Section 3.2 of Annex II. TERMS OF REFERENCE - TECHNICAL SPECIFICATIONS an analytical breakdown of the expected deliverables can be found.

The contract duration is stated in paragraph 2.20 (Duration of Contract Execution) of PART A: INSTRUCTIONS TO ECONOMIC OPERATORS of the Tender Documents which states “Until 1st of February 2020, from the date of commencement of the implementation of the Contract Scope”.
